MBI & MBO Club. The Club is sponsored jointly by Enterprise Investors and Pedersen & Partners. It focuses on the issues and challenges facing ambitious managers who would like to become or already are company owners, through a management buy-in (MBI) or management buy-out (MBO). The Club operates as an informal network of a select group of successful top managers from the countries of Central & Eastern Europe and is a forum for identifying opportunities, exchanging ideas, and developing contacts. Club meetings take place usually two times a year in each of the affiliated countries. KRIO Institute. KRIO Institute Cell and Tissue Bank started activity in December 1998. Primary goal of the activity was freezing and preserving sperms of males whose fertility may be endangered due to the applied operation or therapy. KRIO enlarged its activity in 2000 to donor semen service. Since then about 3.000 donor candidates have been tested. From the very beginning more than 2.500 children were born by means of KRIO. Now KRIO is Hungary's oldest and biggest cryobank storing more than 10. 000 cord blood and more than 20.000 semen samples and conducting more than three thousand cord blood drawings a year. It is the first service provider receiving licence for freezing and preserving stem cells in Hungary. The institute is a member of the FamiCord Group, one of the biggest stem cell bank networks in Europe preserving a total number of 50 000 stem cells. In 2010, KRIO Institute was the first in Hungary and the fourth in Europe to be accredited by AABB (American Association of Blood Banks), an international association representing individuals and institutions involved in the field of transfusion medicine and cellular therapies. In 2010 and 2011 KRIO has performed two successful stem cell transplantations for children suffered from leukaemia. These transplantations were the first in Hungarian medical history which was performed from the family cord blood bank.
